WITNESSETH, That whereas Richard J. Kania was appointed Commissioner under an order of the Superior Court of New Hanover County, North Carolina, in the tax foreclosure proceeding entitled "County of New Hanover vs. Rufus Russ, et al.", (File #21 CvD 171); and was directed by the order as Commissioner to sell the property hereinafter described at public sale after due advertisement according to law;

Whereas Richard J. Kania, Commissioner, did on the 18th day of November, 2022, offer the land hereinafter described at a public sale at the New Hanover County Courthouse door, in Wilmington, North Carolina and Will Jackson became the last and highest bidder for said land for the sum of \$71,925.00; and the sale having been confirmed, and Richard J. Kania, Commissioner, having been ordered to execute a deed to the purchaser upon payment of the purchase money;

Now, in consideration of the premises and the sum of \$71,925.00, receipt of which is hereby acknowledged, Richard J. Kania, Commissioner, does, by these presents, hereby bargain, sell, grant, and convey to Grantee, and its successors, heirs and assigns, that property situated in New Hanover County, North Carolina, and described as follows:

BEGINNING at a point in the Eastern line of Seventh Street, Fifty (50) feet South from its intersection with the Southern line of Brunswick Street, runs thence Eastwardly and parallel with Brunswick County fifty three (53) feet, thence Southwardly and parallel with Seventh Street, twenty four (24) feet to the Northern line of the right-of-way of the Atlantic Coast Line Railroad, thence Southwestwardly along said Northern line of said right-of-way of the Eastern line of Seventh Street, thence Northwardly along said Eastern line of Seventh Street fifty (50) feet to the Beginning - same being part of Lots 1 and 2, in Block 267 - according to the present official plan of said City of Wilmington, North Carolina.

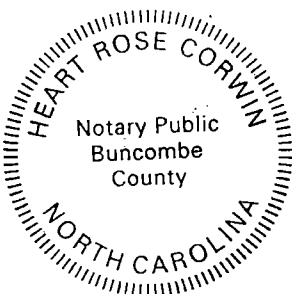
