Tract 1:

BEGINNING a point in the eastern line of Fifth Street, one hundred five (105) feet southwardly from the southern line of Church Street and running thence southwardly along the eastern line of Fifth Street thirty-six (36) feet; thence eastwardly parallel with Church Street sixty-six (66) feet; thence northwardly parallel with Fifth Street thirty-six (36) feet; thence westwardly parallel with Church Street sixty-six (66) feet to point of beginning, the same being part of Lots 2 and 3, in Block 91, according to the official plan of Wilmington, NC. Being the same property described as the First Tract in that deed to George Karafas and wife, Angelina Karafas recorded in Book 1133 at Page 1297 of the New Hanover County Registry.

Tract 2:

Beginning at a set iron pipe in the western line of Price's Alley (10' public right of way), said beginning point being located South 61° 55' 36" East 59.49', North 84° 23' 00" East 117.60' and South 05° 37' 00" East 106.00' from the centerline intersection of Fifth Street (99' public right of way) and Church Street (66' public right of way), and running thence from said beginning point, along the western line of Price's Alley South 05° 37' 00" East 35.00' to a set iron pipe; running thence along the northern line of a tract of land conveyed to Kevin Hoey in Deed Book 1818 Page 116 of the New Hanover County Registry South 84° 23' 00" West 42.00' to a point; running thence the same bearing 9.60' to a point marking the southeastern corner of a tract of land recorded as Tract 1 of Deed Book 1133 Page 1297 of said Registry; thence with the eastern line of said tract North 05° 37' 00" West 35.00' to a point; thence with the southern line of a tract of land conveyed to Richard R. Chinn in Deed Book 1558 Page 996 of said registry North 84° 23' 00" East 9.60' to a set iron pipe; running thence North 84° 23' 00" East 42.00' to the point of beginning, the same being all of Tract 2 as described in Deed Book 1133 Page 1297 of said Registry and also a 9.60' gap located between said Tract 2 and Tract 1.

Tract 3:

BEGINNING at a point in the eastern line of Front Street, said beginning point being 99 feet north of the intersection of the eastern line of Front Street with the northern line of Church Street, running thence eastwardly and parallel with Church Street 170 feet; thence northwardly parallel with Front Street 33 feet, thence westwardly parallel with Queen Street 170 feet to the eastern line of Front Street, thence southwardly and along the eastern line of Front Street, 33 feet to the point of beginning, same being part of Lot No. 5 in Block 100 according to the official plan of the City of Wilmington.

TOGETHER WITH a perpetual easement and right of way in, to, through and over the following described alleyway:

BEGINNING at a point in the western line of Second Street, 122 feet north of the intersection of the western line of Second Street and the northern line of Church Street, and running thence northwardly

with the said northern line of Second Street, ten feet, thence westwardly and parallel with Church Street 160 feet to the above described land, thence southwardly with the eastern line of the above described land, ten feet, thence eastwardly and parallel with Church Street 160 feet to the point of beginning, all of the above described property being in Block No. 100, Lot No. 5, according to the official plan of the City of Wilmington.

BEING the same property conveyed to Georgios A. Karafas and wife, Angelici T. Karafas recorded in Book 941 at Page 739 of the New Hanover County Registry.

SUBJECT, nevertheless, to an alley easement, right of way in, to and over the eastern ten feet of the first described lot unto the owner of the lot immediately adjoining to the south and being the lot previously conveyed to Motte by Campbell.

Tract 4:

BEGINNING at the intersection of the northern line of Red Cross Street with the western line of Third Street; running thence northwardly along said line of Third Street 134 feet; thence westwardly parallel with Red Cross Street 50 feet; thence southwardly parallel with Third Street 134 feet to the northern line of Red Cross Street; thence eastwardly along said line of Red Cross Street 50 feet to the beginning; and being the same property conveyed to George A. Karafas and wife, Angelike G. Karafas recorded in Book 1453 at Page 1163 of the New Hanover County Registry.
